## 1. Purpose of Expression of Interest (EOI)

This Expression of Interest (EOI) seeks to identify and engage capable firms, investors, and development partners interested in the development of tourism Project at Anathazhchira, Thiruvananthapuram on PPP Mode. The proposed project aims to transform the site into a vibrant, inclusive destination that seamlessly blends local leisure amenities with transit-oriented tourism. Through a thoughtful integration of ecological design, cultural programming, and smart infrastructure, the development aspires to create a dynamic retreat that serves both the resident community and short-stay visitors. The scope and vision outlined in this EOI pertain specifically to the project site detailed herein.

This EOI document provides interested parties with relevant information and invites suggestions and responses regarding:

1. Project concept and indicative project components.
2. Total proposed capital investment, including own investment.
3. Proposed development model (e.g., lease, concession, revenue share, or other PPP models)
4. Revenue sharing models proposed for KTIL and the Government.
5. Suggestions for ensuring successful private participation-based development.
6. Feedback on any anticipated concerns or issues.
7. Expected duration of lease period.

## 2. Department of Tourism, Government of Kerala

The Department of Tourism, Government of Kerala plays a pivotal role in shaping and promoting tourism across the state. Its primary responsibilities include developing tourist destinations, enhancing infrastructure, and marketing Kerala as a global travel hotspot. The department actively collaborates with both central and state governments, as well as private stakeholders, to improve the quality of tourism services and facilities.

## 3. Kerala Tourism Infrastructure Limited (KTIL)

Kerala Tourism Infrastructure Ltd or (KTIL), is a Government of Kerala undertaking under Kerala Tourism Department, established in August 1989 to promote tourism investment and to develop Tourism infrastructure in Kerala. KTIL was conceived to identify tourism infrastructure needs of the state and bridge any identified gaps.

### PUBLIC PRIVATE PARTNERSHIP

KTIL pioneered the Public Private Partnership (PPP) model in tourism infrastructure development in Kerala. Following Projects are under the Public Private Partnership:

- M/s Oberoi Kerala Hotels and Resorts Limited (with Oberoi Group)

## 4. Project Rationale

Anathazhchira, situated in Pallippuram in the Thiruvananthapuram district, is an emerging attraction in the region. Covering approximately 15.7 acres including 03 acres of land and 12.7 acres of waterbody, it offers a distinctive combination of natural beauty and promising development potential.

Anathazhchira offers a rare combination of natural water expanse, proximity to major tech and education hubs, and excellent multimodal connectivity, making it an ideal candidate for innovative tourism development. The site's potential to attract tech professionals, wellness seekers, and both short-stay and leisure tourists addresses the growing demand for new experiences beyond conventional destinations.

By leveraging Kerala's reputation as a hub for wellness, eco-tourism, and premium hospitality and aligning with the State's vision to increase tourism's GDP contribution- the project presents a sustainable, high-value investment opportunity for public-private partnership. The focus on immersive leisure and wellness supports long-term asset value, regional economic growth, and community engagement.

## 5. Indicative Project Development Opportunities

### 5.1 Location Overview

Anathazhchira is strategically situated in the rapidly urbanizing peri-urban corridor of Thiruvananthapuram district, Kerala, renowned for its dynamic blend of technology and tourism. The site is uniquely positioned at the crossroads of major tech and education hubs- including Technopark Phase IV (1 km), the Digital University Kerala (3 km), and the Asian School of Business (2 km)- making it highly accessible to professionals, students, and a diverse tourist demography.

Multimodal connectivity further enhances its appeal: Thiruvananthapuram International Airport (19 km), Thiruvananthapuram Central Railway Station (23 km), NH66 (3 km), and the proposed Lite Metro (2 km) ensure swift access for transit travelers, weekend explorers, and inbound tourists. The site's proximity (<1 hour) to Varkala, Kovalam, and other major natural and heritage destinations adds to its locational advantage.

Essential infrastructure surrounds the site, including major roads (NH66, SH1), hospital and fire station facilities (within 8 km), and the Planned Freedom Park by Kerala Startup Mission on the fringes. The greater urban agglomeration supports multiple five-star hotels (100+ rooms within 10 km), facilitating hospitality expansion and seamless visitor integration.

The site's visibility, unfragmented boundaries, and adjacency to vibrant residential and tech zones make it ideal for investment in tourism infrastructure. Anathazhchira is set to emerge as a barrier-free urban oasis, harmonizing ecological, cultural, and nightlife elements—fully leveraging Kerala's unique blend of nature, wellness, and technological progress.



## 5.2 Project Vision

"To transform Anathazhchira into a vibrant, sustainable urban oasis located at the crossroads of Thiruvananthapuram's Tech and Tourism corridor that harmonizes ecological sustainability, inclusive access, and cultural vitality, to create immersive experiences for visitors, foster nightlife, community engagement, and celebrate Kerala's natural and cultural heritage."

## 5.3 Site Details

The proposed site for tourism development of 15.76 Acres falls within Thiruvananthapuram district, Block No. 8 Resurvey No. 94. Encompassing approximately 12.7 acres of water body and 3 acres of designated tourism land, Anathazhchira offers a flat terrain with gentle undulations—suitable for water-based recreational activities, eco-tourism initiatives, and immersive leisure experiences. The land is jointly owned by the Revenue Department and the Andoorkonam Grama Panchayat, ensuring institutional support for sustainable development.

Encompassing approximately 12.7 acres of water body and 3 acres of designated tourism land, Anathazhchira offers a flat terrain with gentle undulations—suitable for water-based



recreational activities, eco-tourism initiatives, and immersive leisure experiences. The land is jointly owned by the Revenue Department and the Andoorkonam Grama Panchayat, ensuring institutional support for sustainable development.

Anathazhchira is envisioned as a vibrant, inclusive space that blends local leisure with transit tourism. By integrating ecological design, cultural experiences, and smart infrastructure, the site becomes a dynamic retreat for both residents and short-stay visitors.

### *1. Urban Oasis and nightlife*

The land zone offers barrier-free gardens, wellness pods, and interactive tech spaces tailored for youth, families, and professionals. Night markets, amphitheatres, and cultural workshops bring Kerala's heritage to life, while promoting community engagement and nightlife.

### *2. Water based experiences*

Floating cottages, dining pavilions, and adventure activities like kayaking and ziplining create a serene yet exciting backwater experience. LED-lit bridges and botanical walkways enhance the scenic charm and event potential of the water zone.

### *3. Transit- Friendly Facilities*

Smart pods, 24x7 food courts, and relaxation zones cater to in-transit travellers. Located near major transport hubs and tourist circuits, the site offers quick rejuvenation and seamless access for domestic and international visitors.

### *4. Cultural and Tourist Integration*

An interpretation centre and tourist facilitation zone help visitors connect with Kerala's stories, ecology, and travel routes. Light and sound trails themed around folklore add a magical touch to evening visits.

### *5. Smart Infrastructure and Accessibility*

With EV charging stations, digital kiosks, multilingual guides, and QR-coded maps, the site ensures convenience and inclusivity for all. Parking and accessibility features support high footfall and diverse visitor needs.

While the proposed development framework for Anathazhchira outlines a vibrant, inclusive destination blending local leisure and transit tourism, applicants are encouraged to submit alternative or complementary concepts that align with the overarching vision stated in 5.2 (for E.g. Floating Cottages, Live BBQ points, Butterfly Park, Yoga centre etc.).

Innovative ideas that enhance ecological sustainability, cultural engagement, and smart infrastructure are welcome, provided they contribute meaningfully to the site's transformation into a dynamic retreat along with safe and engaging nightlife experience for the visitors.

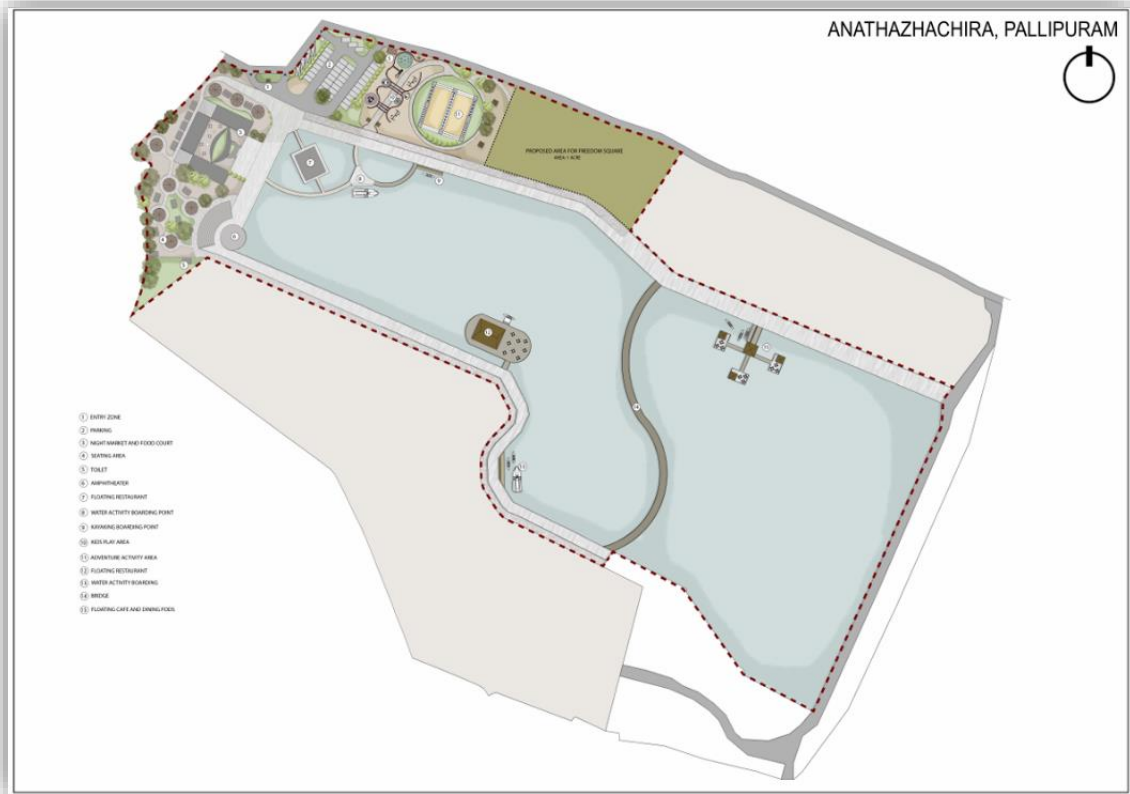


Figure 1 Overall View of Project Site; Image for Representation Only.

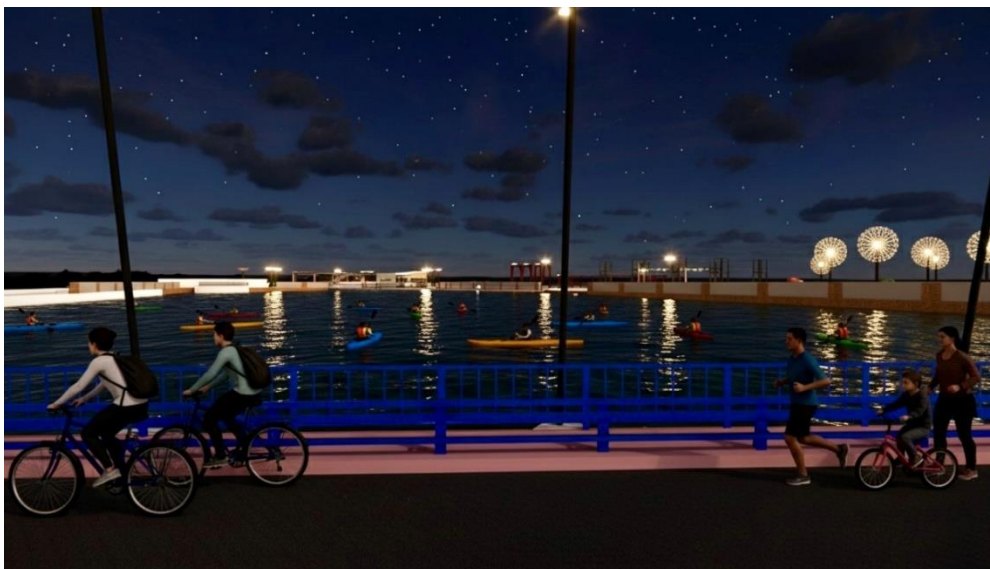


Figure 2: Cycling track and walkway on the bay

## 6. Roles and responsibilities

### I. KTIL, Department of Tourism, Government of Kerala

- a) Authority may provide the designated land area as available under the Authority in accordance with Government guidelines / conditions based on a transparent application process in subsequent stages, if any.
- b) The ownership or title of the land shall continue to vest with Authority always and only the lease / concession/ rights of the use of the land or the structures built on it shall be transferred by the Authority based on the mode of development / project type / investment / rules and regulation and conditions that will be detailed out during the bidding stage.
- c) Facilitation and support for coordination with the participating Government agencies, state/ district authorities, and stakeholders.
- d) Maximum Period shall be based on the type of development, investment etc.
- e) Any other facilitation required, within the Authority's framework.

## II. Investor/Firm/Agency

- a) Investor/firm shall be responsible for conducting feasibility study, ensuring insurance, safety and compliance to statutory provisions, rules and regulations, and social context.
- b) Investor/firm must create a detailed project plan based on Design, Build, Finance, Operate and Transfer (DBFOT) mode on PPP.
